INTRODUCTION

This cabinet is designed for budget purposes (cheaper) i.e. hobby or part time use. There is no dust extractor but is fitted with a

filter bag at the back to trap the dust. The blasting gun is of the trigger gun type and is fitted with a tungsten carbide nozzle.

Light is provided by an energy saving light which prevents build up of heat.



TROUBLESHOOT

PROBLEM	REASON	SOLUTION
1 No grit at gun 	a) No grit	Fill up hopper (grit)
	b) Item blocking hopper - Caused by moisture - Large particles blocking hopper	Place finger at nozzle, this will send
	c) Item blocked in gun	Remove grub screw and clear obstacle in nozzle
	d) Item lodged in bottom part of cabinet	Undo elbow, drain cabinet and sieve grit. Thereafter put back to together.
2 Slow Production 	a) Breathing hole under cabinet blocked	Undo blockage
	b) Airjet or nozzle worn out or closed off	Once a week – turn nozzle and airjet 90° for longer performance
	c) Air supply hose has been restricted to less than ½ inch	Provide ½ inch air
3 Misting up of glass caused by angle of blasting	a) Blasting too close to the glass or blasting	Blast away from glass to avoid glass fro misting up
4 Too much dust 	a) Dust bag full. Please note : The finer the grit the quicker it turns to dust	Take dust bag off and clean. Bag can be washed.
	b) Dust emerging from side and back of cabinet	Foam rubber worn or warped door.

Glassbeads should be blasted at 2-4BAR and not at 6-7BAR to lessen the consumption of glassbeads
